1. Foreword

Article 5.1 of the Regulation provides that for the purposes of the Regulation, GME shall adopt the units of measurement indicated in the Technical Rules.

2. Units of measurement

In the PAR:

- a) the unit of measurement of the tradable as part of the procedures for the allocation of capacity during the thermal year, the allocation of residual capacity in thermal year(1), the capacity no longer available in auction amount and within the procedures for the allocation of annual and multi-annual capacity(**)is the slot:
- b) the unit of measurement of the currency is the Euro, specified with two decimal places;
- c) the unit of measurement for unit prices of the regasification capacity and ancillary costs is Euro/m3liq, specified with 6 (six) decimal places.

Ex: the regasification company wishes to provide 3 unloading slots for each month until the end of the thermal year (in the example, the residual product in thermal year consists of 8 months). If the participants indicates an amount equal to 1 slot, this implies a purchase offer of 8 slots (namely 1 slot * for each of the 8 months), namely equal to 1 residual product in thermal year. If a participant indicates an amount equal to 2 slots, this implies a purchase offer of 16 slots (namely 2 slots * each of the 8 months), namely equal to 2 residual products in thermal year.

¹ The residual capacity in thermal year consists, pursuant to art. 2, paragraph 2.2, letter f), of the Regulations:

⁻ of a unloading slot, for each month, starting from the month following the auction and until the end of the thermal year, or

⁻ of any unloading slots still available for allocation, each referred to individual months of the thermal year, even if not consecutive to each other.

^(**) For products relating to multi-annual contributions with expression of interest tradeable on the OLT segment of the PAR, the unit of measurement expressed in "slots", in accordance with the provisions of the OLT regasification code, shall refer to each of the thermal years included in the multi-annual product allocated.

E.g.: The regasification company wishes to allocate 3 unloading slots for each of the 2 thermal years included in the product allocated. If the participant indicates an amount of 1 slot, this makes up an overall purchase offer of 2 slots (i.e. 1 slot * for each of the two years). If a participant indicates an amount of 2 slots, this makes up an overall purchase offer of 4 slots (i.e. 2 slots * for each of the two years).
