

1) Preconditions to enter bids/offers into the RWE Supply & Trading GmbH (following "RWEST") order book or auction

(a) Market participants with existing contractual relationship to RWEST

Such participants do not need to provide us additional documents before entering bids/offers into our order book or auction.

(b) Market participants with no contractual relationship to RWEST

Such participants are required to send us the following documents at the same time when posting its application to enter demand bids/offers into the RWEST order book or auction for credit and compliance approval .

The required documents are:

- (i) a current certified copy of an extract from Party B's entry in the Commercial Register ("Handelsregister") or the equivalent, evidencing Party B's existence and authority and capacity to enter into this Agreement and the Individual Contracts contemplated hereby; and
- (ii) audited accounts of the last three years; consolidated if the company is a consolidated entity; and
- (iii) ownership structure if not obvious from the above documents.

2) Terms and Conditions for the purchase of Natural Gas from RWEST

(a) Market participants with existing contractual relationship to RWEST governed by a General Agreement Concerning The Delivery And Acceptance Of Natural Gas ("General Agreement")

Participants that are party will purchase Natural Gas from RWEST under the existing legal framework.

Any transaction to be agreed at GME Platform will be regarded as Individual Contract in the meaning of §1.1 of the General Agreement and will be governed by the mutually agreed legal and credit terms of that General Agreement.

The Delivery Point for such Individual Contract is Punto di Scambio Virtuale ("PSV") in Italy and RWEST (Party A) is the Seller.

(b) Market participants with no contractual relationship to RWEST governed by a General Agreement

Participants that are not already party to a General Agreement shall purchase Natural Gas from RWEST under the Terms and Conditions as defined in the attached EFET General Agreement Concerning The Delivery And Acceptance Of Natural Gas (Annex 1) and its Elections Sheet (Annex 2).

Notwithstanding the irrevocable acceptance of the Terms and Conditions and for documentation purposes only; the participant shall without unreasonable delay provide RWEST with a countersigned copy of the EFET General Agreement Concerning The Delivery And Acceptance Of Natural Gas and its Elections Sheet after concluding the first transaction on GME Platform. All participant specific information (Effective Date, § 14 and §23) shall be included in such copy.


