- 1 PARTIES This Agreement on the Terms of Use is a term into between Gestore dei Mercati Energetici S.p.A., having its registered office in Viale Marescialla ilsuaki, 122-124, 00197 Rome, VAT no. and taxpayer's code 06208031002 (GME) and the individual ser (ind. ilual, organisation or other entity) acting in his/her own behalf and/or on behalf of the organization that he/she represents ("User").
- 2 ACCEPTANCE These Terms of Use of the deemed to have been accepted as of the date when GME receives the same, duly accepted and so add by the User and accompanied by a copy of an identity document and, if the applicant is an organisation of a declaration issued in accordance with Decree of the President of the Republic no. 445 of a pacer ber 2000 or other document based on which GME will carry out a substantial equivalence evaluation certifying the powers of representation of the signer of the application, and by the related identity document.
