1. FOREWORD

Article 2, para. 2.1 nn) of the Rules governing the regulated market and the platform for registering bilaterals of guarantees of origin (hereafter P-GO Rules) defines the production period as the reference time period of energy production from renewables related to the GOs, as defined in the Technical Rules.

Article 2, para. 2.1 b) of the P-GO Rules defines the access profile or operating profile as follows: *i.* if the Participant is present in the GO Registry with a single access profile, the access profile - among those identified in the Technical Rules - that GSE has assigned to the Participant upon entry into the GO Registry, through which the Participant takes part in the M-GO and/or the PB-GO; *ii.* if the Participant is present in the GO Registry with multiple access profiles, each of the access profiles - among those identified in the Technical Rules - that GSE has assigned to the Participant upon entry into the GO Registry, through which the Participant takes part in the M-GO and/or the PB-GO.

Article 6, para. 6.1 of the P-GO Rules provides that access to GME's information system shall take place through the Internet, in accordance with the procedures and within the time limits defined in the Technical Rules, or by any other means defined therein.

Article 10, para. 10.1 of the P-GO Rules provides that Participants shall have access to the P-GO under special procedures defined in the Technical Rules. These procedures shall guarantee the identification of Participants and authenticate their transactions.

Under Article 18, para. 18.1 *bis* of the P-GO Rules, if a Participant admitted to the M-GO wishes to be authorised to enter orders into the M-GO, he/she/it shall declare to hold at least one active ownership account in the GO Registry, when registering with the P-GO system, as indicated in the Technical Rules.

Under Article 18, para. 18.1 *ter* of the P-GO Rules, if a Participant admitted to the PB-GO (and automatically admitted to the GO Bulletin Board as well) wishes to be authorised to make registrations on the PB-GO or carry out transactions on the GO Bulletin Board,

he/she/it shall declare to hold at least one active ownership account in the GO Registry, when registering with the P-GO system, as indicated in the Technical Rules.

Under Article 18.1 *quater* of the P-GO Rules, if a Participant admitted only to the GO Bulletin Board wishes to be authorised to carry out transactions on the same Bulletin Board, he/she/it shall declare to hold at least one ownership account with one of the European Energy Certificate System (EECS) Registries, different from the GO Registry, when registering with the P-GO system, as indicated in the Technical Rules.

Article 18, para. 18.3 of the P-GO Rules provides that the data mentioned in para. 18.2 shall have effect on the dates specified in the Technical Rules.

Article 23, para. 23.4 of the P-GO Rules provides that each of the types of GO mentioned in para. 23.3 above shall be further classified on the basis of the production periods defined in the Technical Rules.

Article 24, para. 24.4 of the P-GO Rules provides that the opening and closing hours of the sessions of the M-GO shall be established in the Technical Rules.

Article 24, para. 24.8 of the P-GO Rules provides that a Participant may take part in the M-GO only through one or multiple access profiles – as identified in the Technical Rules – corresponding to the single access profile or to the multiple access profiles through which he/she/it is present in the GO Registry, respectively.

Article 24, para. 24.9 of the P-GO Rules provides that, if a Participant has multiple access profiles, his/her/its participation in the M-GO shall take place separately for each access profile, under the procedures and within the time limits established in the Technical Rules.

Article 25, para. 25.1 of the P-GO Rules provides that Participants shall enter trading orders into the M-GO under the modalities and within the time limits indicated in the Technical

Rules, specifying at least the following data for each type of GO and the related production period:

- a) identification code of the Participant entering the order;
- b) type of order (buy/sell);
- c) offered volume;
- d) unit price for the offered volume.

Article 28, para. 28.1 of the P-GO Rules provides that, within the time limit indicated in the Technical Rules, GME shall publish the results of the M-GO session, specifying at least the following data and information for each type of GO and the related production period:

- a) minimum price and maximum price of the session;
- b) volume traded in the session;
- c) reference price of the session;
- d) volume and price of each concluded transaction in anonymous form.

Article 32, para. 32.1 of the P-GO Rules provides that requests for registration on the PB-GO shall be entered under the procedures and within the time limits defined in the Technical Rules.

Article 32, para. 32.2 of the P-GO Rules provides that a Participant may take part in the PB-GO only through one or multiple access profiles – as identified in the Technical Rules – corresponding to the single access profile or to the multiple access profiles with which he/she/it is present in the GO Registry.

Article 32, para. 32.3 of the P-GO Rules provides that, if a Participant has multiple access profiles, his/her/its participation in the PB-GO shall take place separately for each access profile, under the procedures and within the time limits established in the Technical Rules.

Article 32, para. 32.10 of the P-GO Rules provides that a request for registration in the PB-GO entered by a selling Participant, pursuant to paragraph 32.5, shall be deemed to have been concluded when:

- a) if it is a request for registration without technical adequacy verification, it is accepted by the buying Participant and is valid pursuant to article 33;
- b) if it is a request for registration with technical adequacy verification, it is accepted by the buying Participant, valid pursuant to article 33 and technically adequate pursuant to article 34, subject to the successful outcome of the verifications related to additional requirements as defined in the Technical Rules, if applicable.

Article 33, para. 33.4 of the P-GO Rules provides that GME shall verify the validity of requests for registration in the PB-GO pursuant to the preceding paragraph 32.5, based on the time of entry of the requests by the selling Participant, except as set forth in the Technical Rules.

Article 34, para. 34.2 of the P-GO Rules provides that GME shall verify the technical adequacy of requests for registration entered into the PB-GO, based on the time of entry of the requests by the selling Participant, except as set forth in the Technical Rules.

Article 35, para. 35.1 of the P-GO Rules provides that, in compliance with the procedures and within the time limits specified in the Technical Rules, GME shall publish at least the following data and information (in aggregated form) about the registrations of bilateral transactions of GOs that have been concluded on the PB-GO:

- a) registered volumes of GOs with the specification of their types as per article 23, para. 23.3 and of the related production period as per article 23, para. 23.4;
- b) minimum price and maximum price;
- c) average price weighted for the registered volumes.

Article 35, para. 35.3 of the P-GO Rules provides that, for the purposes of the transfer of ownership of the GOs registered in accordance with article 32, para. 32.4 b), GME shall notify GSE of the conclusion of the related registrations, under the procedures identified by GME and GSE in an appropriate agreement and within the time limits indicated in the Technical Rules.

Article 38, para. 38.1 of the P-GO Rules provides that, in compliance with the procedures and within the time limits specified in the Technical Rules, GME shall publish at least the following data and information (in aggregated form) about the registrations of bilateral transactions of GOs carried out as per article 37 (Registration of the Results of Auctioning Procedures):

- a) registered volumes of GOs with the specification of their types as per article 23, para. 23.3 and of the related production period as per article 23, para. 23.4;
- b) minimum price and maximum price;
- c) average price weighted for the registered volumes.

Article 39 *quater*, para. 39 *quater*.1 of the P-GO Rules provides that Participants may ask other Participants in the GO Bulletin Board to be designated as preferred counterparties, in accordance with the procedures and within the time limits indicated in the Technical Rules.

In compliance with Article 39 *quater*, para. 39 *quater*.2 of the P-GO Rules, Participants may – under the procedures and within the time limits indicated in the Technical Rules – change or delete the requests that they have submitted under the preceding para. 39 *quater*.1, as long as such requests have not been accepted or rejected by their recipients under the following para. 39 *quater*.3.

Pursuant to Article 39 *quater*, 39 *quater*.3 of the P-GO Rules, Participants receiving the requests referred to in the preceding para. 39 *quater*.1 may accept or reject them under the procedures and within the time limits defined in the Technical Rules.

Article 39 *quater*, para. 39 *quater*.5 of the P-GO Rules provides that the designation as a preferred counterparty, resulting from acceptance of the request referred to in the preceding para. 39 *quater*.1 may be cancelled by each of the preferred counterparties under the procedures and within the time limits indicated in the Technical Rules.

Article 39 *quinquies*, para. 39 *quinquies*.1 of the P-GO Rules provides that Participants shall submit sale and purchase ads in compliance with the procedures and within the time limits defined in the Technical Rules.

Article 39 *quinquies*, para. 39 *quinquies*.3 b) of the P-GO Rules establishes that, for each ad, Participants may specify not only the required minimum information but any additional information as indicated in the Technical Rules in accordance with the procedures and within the time limits established therein.

Under Article 39 *quinquies*, para. 39 *quinquies*.4 of the P-GO Rules, Participants may view sale and purchase ads on the GO Bulletin Board by selecting – under the procedures laid down in the Technical Rules – one or more of the minimum items of information contained in the ad.

Article 39 *quinquies*, para. 39 *quinquies*.6 of the P-GO Rules provides that, under the procedures and within the time limits established in the Technical Rules, Participants may change or delete their ads, as long as there have been no expressions of interest therein. The GO Bulletin Board shall display the change or deletion of the ad under the procedures indicated in the Technical Rules.

Article 39 *quinquies*, para. 39 *quinquies*.8 of the P-GO Rules provides that, under the procedures and within the time limits set forth in the Technical Rules, GME shall delete the ads placed by Participants who/which have been suspended or excluded from the GO Bulletin Board.

In accordance with Article 39 *sexies*, para. 39 *sexies*.1 b) of the P-GO Rules, after submission of ads, GME shall validate them by verifying only that they have been submitted under the procedures and within the time limits indicated in the Technical Rules.

Article 39 *septies*, para. 39 *septies*.1 of the P-GO Rules provides that the ads present on the GO Bulletin Board shall be displayed in anonymous form with their identification code and the information indicated in the Technical Rules.

Article 39 *septies*, para. 39 *septies*.2 of the P-GO Rules provides that any Participant

who/which has not been suspended from the GO Bulletin Board may view all the ads placed by other Participants under the procedures and within the time limits specified in the Technical Rules.

Article 39 *septies*, para. 39 *septies*.3 of the P-GO Rules provides that a Participant may select and express interest only in the ads placed by a preferred counterparty under the procedures and within the time limits set forth in the Technical Rules.

Article 39 *septies*, para. 39 *septies*.4 of the P-GO Rules provides that, before expressing interest in an ad placed by a preferred counterparty, a Participant may – in compliance with the principles laid down in the preceding article 3 – activate the messaging option that is available on the GO Bulletin Board, in accordance with the procedures and within the time limits indicated in the Technical Rules.

Article 39 *septies*, para. 39 *septies*.5 of the P-GO Rules provides that the expression of Interest made by a preferred counterparty Participant shall be considered to have been automatically confirmed by the Participant proposing the ad upon submission of the same expression of interest. In this instance, the information system of the GO Bulletin Board shall communicate the data and information concerning the respective counterparty to both Participants, and any remaining information concerning the ad to the Participant expressing interest therein, in accordance with the procedures and within the time limits indicated in the Technical Rules.

Article 39 *septies*, para. 39 *septies*.6 of the P-GO Rules provides that any ad in which there has already been an expression of interest may be published again on the GO Bulletin Board by the proposing Participant as a new ad, under the procedures and within the time limits indicated in the Technical Rules.

Under Article 39 *septies*, para. 39 *septies*.7 a) of the P-GO Rules, if, after an expression of interest, a long-term GO contract associated with the ad is actually concluded between the related counterparties and if both counterparties hold an ownership account in the GO

Registry, they shall register the transfer of the GOs associated with the contract on the PB-GO, as provided for in Title III, Section II, Subsection I of the same Rules, by selecting the appropriate option to associate the ad with the request for registration, under the procedures and within the time limits indicated in the Technical Rules. The registration is allowed only if both counterparties have not been suspended from the GO Bulletin Board.

Article 67, para. 67.1 of the P-GO Rules provides that, within GME's information system, Participants holding multiple access profiles may move their GOs from one of their ownership accounts to another of their ownership accounts, each associated with each of the above profiles, under the procedures and within the time limits established in the Technical Rules.



2. ACCESS TO THE INFORMATION SYSTEM OF THE P-GO

2.1 Registration of a company

After receiving the notification of admission to the P-GO from GME and with a view to making transactions in the M-GO and/or registrations on the PB-GO, and/or operating on the GO Bulletin Board, the company or individual (in the latter case, follow the instructions of para. 2.2 below) must register with the platform.

You may register through the “**Registrazione società**” (registration of the Participant - company) link, available at www.mercatoelettrico.org, in the “The Markets/Access to GME's markets/P-GO/**Access to the P-GO**” section, and fill in the following form (Figure 1):

In the first part of the form, specify whether you have an ownership account, by selecting whether you hold an ownership account in:

- **the GO Registry managed by GSE,**
- or
- **another European Energy Certificate System (EECS) Registry, different from GSE's Registry.**

After making the above choice, complete the following compulsory fields:

- Platform where you wish to operate:

- if you have declared to hold an ownership account in GSE's GO Registry¹, specify the **Platform on which you wish to operate** by selecting the Platform/s indicated in the market participation application, i.e. M-GO and/or PB-GO (GO Bulletin Board²);
- if you have declared to hold an ownership account in **one of the EECS Registries**³, **different from GSE's Registry**, your selection will be automatically valid only for the GO Bulletin Board⁴;

¹ GME will authorise the applicant to operate on the platform after checking whether he/she/it actually holds the ownership account in the national GO Registry that he/she/it has declared. Consequently, if an applicant has not yet been assigned with an ownership account by GSE but has declared to fulfil such requirement upon registration, he/she/it will not be authorised to operate in the M-GO and/or on the PB-GO, and/or on the GO Bulletin Board until GME has successfully verified the fulfilment of such requirement.

If, after being authorised to operate in the M-GO and/or on the PB-GO, the Participant wishes to operate on the GO Bulletin Board through an ownership account held in another EECS Registry, different from GSE's GO Registry, he/she/it will have to submit to GME a request for authorisation to operate on the GO Bulletin Board, after submitting a request for exclusion from the P-GO.

² It is worth pointing out that the authorisation to operate on the GO Bulletin Board will be deemed to have been automatically requested when the Participant has selected the authorisation to operate on the PB-GO.

³ If, after being authorised to operate on the GO Bulletin Board, the Participant wishes to operate thereon through an ownership account held in the national registry of GOs, he/she/it will have to submit to GME a request for authorisation to operate on the PB-GO. Indeed, if a party holds an ownership account in GSE's national GO Registry and wishes to operate on the GO Bulletin Board through such ownership account, he/she/it will have to submit a request for authorisation to operate on the PB-GO; after obtaining such authorisation, he/she/it will be automatically authorised to carry out activities on the GO Bulletin Board. Note that a party holding an ownership account in GSE's Registry may request to be authorised to operate in the M-GO as well.

After being authorised to operate with an ownership account held in GSE's national GO Registry, a Participant will lose his/her/its authorisation to operate on the GO Bulletin Board with the foreign account code originally assigned by GME.

⁴ If you hold an ownership account in another EECS Registry, different from GSE's Registry, you will be able to operate only on the GO Bulletin Board.

- **ISO code – VAT number:** enter the code of your country (drop-down menu) and your VAT number. If the taxpayer's number of the company matches its VAT number, enter the only available code in both fields;
- **Password:** select the password of the company; the password, to be memorised and kept confidential by the legal representative of the company, will be necessary for the subsequent registration of the access profile/s (para. 2.3 below) and for additional registrations of profiles, if any, in the future.
- **E-mail:** enter the e-mail address of the Legal Representative of the Company. This address will be used by the system for any requests for recovery of the Participant's and operating profile login details.
- **VAT scheme;**
- **Registered office;**
- **Legal representative/s;**
- **Bank details.**

Participants belonging to the administrations referred to in Article 1, para. 209 of Law no. 244 of 24 December 2007 (PA Participants) are required to select "YES" on the drop-down menu.

The system will enable the field of "codice IPA" (code assigned by *Indice delle Pubbliche Amministrazioni* – IPA, Index of Public Administration bodies), thus allowing Participants to enter it, if required.

In fact, the specification of the IPA code, required only for PA Participants, although optional, will be used for subsequent transmission of invoices to these Participants in the manner required by Law 244/2007 and related implementing provisions.

After completing all the fields, give your consent to the processing of your personal data and press "**Invia**" (submit) to enter your registration.

If your registration has been successful, you will get a summary report with the **ID Operatore** (Participant's identification code); this code, to be memorised and kept confidential by the legal representative of the company, will be necessary – together with the password – for the subsequent registration of the access profile/s (para. 2.3 below).

2.2 Registration of an individual

After receiving the notification of admission to the P-GO from GME and with a view to making transactions in the M-GO and/or registrations on the PB-GO, and/or operating on the GO Bulletin Board, the individual must register with the platform.

You may register through the “**Registrazione operatore**” (registration of the Participant – individual) link, available at www.mercatoelettrico.org, in the “The Markets/Access to GME's markets/P-GO/**Access to the P-GO**” section, and fill in the following form (Figure 3):

2.3 Registration of one or multiple profiles of access to the P-GO for a Participant holding one or multiple accounts in GSE's GO Registry





3. MARKET SESSIONS

3.1 Trading in the M-GO

The sessions of the GO market take place from 9:00 to 12:00 of the days posted on GME's website.

The data about each Market Participant is communicated by GSE on the day before the one of each session and it will produce its effects in the session to which such data refers. The system does not allow Participants holding an inactive account with GSE to participate in the M-GO sessions.

Participation in a market session takes place separately for each of the access profiles through which the Participant has been registered with the market under para. 2.3 above. Therefore, if the Participant has multiple access profiles, participation in the M-GO may take place only for each access profile.¹⁶

Each access profile may trade in the M-GO under the related operating criteria defined in the documents: 1) *DM GARANZIE DI ORIGINE – Regole Applicative - v.1 (novembre 2023)* – Ministerial Decree on Guarantees of Origin, Application Rules, v. 1 (November 2023) –; and 2) *Regole Applicative sui controlli relativi all'assolvimento degli obblighi per la riduzione dell'impronta di carbonio nel consumo di energia elettrica degli Energivori (ottobre 2024 e ss.mm.ii)* – Application Rules, monitoring compliance with requirements for reducing the carbon footprint in electricity consumption by energy-intensive companies –; both documents, posted on GSE's website www.gse.it, are summarised as follows:

- **“Produttore”** (producer) → he/she/it may buy and sell all types of GO that are tradable in the M-GO;

- it cannot be the same as any of the latest 5 passwords used.

The data of the form is automatically updated; to freeze the form, select “Non aggiornare” (do not update) in the “**Imposta refresh**” (set refresh) box in the top left part of the form (Figure 9).

By default, the form will display all the buy and sell orders that are present at that time in the market, whatever the type of GOs involved.

The types of GO that are tradable in the M-GO, indicated in Technical Rule no. 06 P-GO, are further classified on the basis of the related production periods.

In the M-GO, each production period consists of a production month/year pair.

In the order books, the GOs for electricity are distinguished by energy source and production period (year and month) and are shown as follows: “**AnnoProduzione_FonteEnergetica_MeseProduzione**” (ProductionYear_Energy Source_ProductionMonth).

In the order books, the GOs for gas, including biomethane, are distinguished by use, CNG or CNG and LNG label, and production period (year and month) and are shown as follows: “**AnnoProduzione_destinazione d’uso CNG (o CNG e LNG) _MeseProduzione**” (ProductionYear_Use_CNG (or CNG and LNG) label, ProductionMonth). In the case GOs for “Gas Transport” and “Gas Other Uses”, their uses specify whether the GO is exportable or not exportable, as well as the CNG or CNG and LNG label; therefore, in the order books, these GOs are shown as follows: “**AnnoProduzione_destinazione d’uso esportabile_CNG (o CNG e LNG) MeseProduzione**” (ProductionYear_Use Exportable CNG (or CNG and LNG) label_ProductionMonth) or “**AnnoProduzione_destinazione d’uso non esportabile CNG (o CNG e LNG)_MeseProduzione**” (ProductionYear_Use Not Exportable CNG (or CNG and LNG) label_Production Month).

Through two drop-down menus (view type – wind), you may select the type of GO and the related production period, choosing (in the first menu) the production year and the energy source (GOs for electricity), or the use (GOs for gas, including the CNG (or CNG and LNG) label, as well as the exportable/not exportable specification, the latter only for GOs gas transport and GOs gas other uses), and the production month (in the second menu).

All the GOs tradable on the P-GO are valid for 12 months, beginning in the month of production of the related energy unit¹⁷.

For each selected type and production period, the top part of the form displays the following general data:

- the reference price of the previous session (average price per MWh, weighted for the related volumes, of all transactions carried out during a given session of the M-GO);
- the prices of the latest three transactions concluded;
- the minimum and maximum price of the transactions concluded in the market until that time;
- the volume of GOs traded until that time.

3.2 Entry of orders into the M-GO

To enter a buy or sell order into the market through your profile²⁰, click on “**Nuova Offerta**” (new order) (top left - Figure 9).

In the order entry form (Figure 14), complete the following fields:

- **Type of order:** purchase or sale;
- **Type of GOs²¹** and related production period, by selecting (in two drop-down menus):
 - year and energy source or use with the CNG (or CNG and LNG) label and the exportability specification, if any;
 - production month;
- **Price per MWh** (excluding VAT), specified with two decimals. The price may have the following values:
 - a) **with price limit**
The specified price is the lower limit for sell orders and the upper limit for buy orders at which the matching is done;
 - b) **market price** (i.e. without price limit)
The orders are matched with the best orders of opposite sign entered into the order book, pursuant to the P-GO Rules.
- **Volume of GOs.** The minimum tradable volume is equal to 1 GO.

3.4 Publication of the results of the M-GO

- minimum price and maximum price;
- volume traded;
- reference price.

4. OPERATING ON THE PB-GO

What is described in this chapter only applies to the transfer of GOs between or among operators holding one or multiple accounts in the national Registry managed by GSE.

4.1 Registrations on the PB-GO

Based on the provisions of the P-GO Rules, the data about the ownership accounts of each operator authorised to participate in the Bilaterals Platform is daily reported by GSE and produces its effects for the registration stages or the sessions of the PB-GO that take place on the same registration day as the one to which such data refers. If the account of a given operator is not active, the system will not permit the registration of transactions on the PB-GO. Participation in the PB-GO takes place separately for each of the access profiles with which the Participant has been registered under para. 2.3 above.

Therefore, if the Participant has multiple access profiles, his/her/its participation in the PB-GO may take place only for each access profile.²²

Each access profile may operate on the PB-GO under the related operating criteria, defined in the documents: 1) *DM GARANZIE DI ORIGINE – Regole Applicative - v.1 (novembre 2023)* – Ministerial Decree on Guarantees of Origin, Application Rules, v. 1 (November 2023) –; and 2) *Regole Applicative sui controlli relativi all’assolvimento degli obblighi per la riduzione dell’impronta di carbonio nel consumo di energia elettrica degli Energivori (ottobre 2024 e ss.mm.ii)* – Application Rules, monitoring compliance with requirements for reducing the carbon footprint in electricity consumption by energy-intensive companies –; both documents, posted on GSE’s website www.gse.it, are summarised as follows:

4.1.1 Registration of a bilateral transaction of sale

In the “**Transazioni bilaterali in vendita**” (bilateral transactions of sale) (Figure 20 – red area), you may enter a bilateral transaction of sale²³ by clicking on “**Nuova offerta**” (new order) and completing the fields in the related window as follows (Figure 21):

- (optional) **Selection of a sale ad in which there has been an expression of interest:** select this option only if both counterparties to the confirmed ad are not suspended from the GO Bulletin Board²⁴ when registering the related bilateral transaction.

If the selection of this option is allowed, select the “**Associa annuncio**” (associate ad) on the list of confirmed sale ads in which the date of delivery of the related GOs has not yet expired. By selecting this option, the fields necessary to register the transaction on the PB-GO will be uploaded together with the corresponding fields of the ad (type of GOs, support received, country of production, EAN code, volume, and price); these fields cannot be changed, unless the association with the selected ad is removed²⁵.

²⁴ Note that, if you register bilateral transactions on the PB-GO without selecting this option (or the option was not selectable because one of the counterparties to the ad was suspended from the GO Bulletin Board), then GME will apply the fees for registrations on the PB-GO as set forth in the P-GO Rules.

²⁵ Note that you must complete the registration of bilateral transactions associated with ads within the delivery date specified therein. After the expiry of this date, you will not be allowed to register a transaction associated with an ad, but you will have to register it without association (and pay the fees applicable on the PB-GO), provided that the GOs covered by the transaction are still tradable.

For each ad, you may carry out one or more bilateral registrations until reaching the total volume covered by the ad for which there has been an expression of interest. Therefore, the **volume** associated with the transaction will correspond to the remaining volume to be delivered (equal to the difference between the original volume covered by the confirmed ad and the volumes already registered and confirmed on the PB-GO in respect of the same ad). This associated volume may be changed by the Participant within the limits of the remaining volume. In any event, the registration of a bilateral transaction referring to an ad may be entered only if any previous registrations made for such ad have been duly processed. Note that, if the request for registration is submitted with “GME’s technical adequacy verification”, the outcome of such processing will depend on the validations made by GME in accordance with Technical Rule no. 03 P-GO.

- **GME’s technical adequacy verifications:** specify the option for registration, i.e.

a) with technical adequacy verification (specified with “True” in “verifica dal GME” (GME’s verification) column – Figure 20 a): after confirmation by the buyer, the transaction awaits validation by GME, which will confirm it on the day before the M-GO session, after checking whether:

- **in the case of transactions with buying counterparties not qualifying as PA Participants**, the buyer has paid the value of the transaction, including VAT, where applicable;
the value of the transaction, unless otherwise specified by the Participant, is paid to the seller with value date on the working day following the one of the M-GO session:
- **in the case of transactions with buying counterparties qualifying as PA Participants**, the buyer has paid the value of the transaction, including VAT where applicable and both the Italian seller and the PA Participant have confirmed the delivery and receipt of the electronic invoice, respectively, as provided by Law 244/2007 and its implementing provisions (see para. 4.1.3.1 below – “Management of transactions with technical adequacy verification and buying counterparties qualifying as PA Participants”);

the ownership accounts of the counterparties are updated only after validation by GME (see Technical Rule n. 03 P-GO);

b) without technical adequacy verification (specified with “False” in “verifica dal GME” column – Figure 20a):

the ownership accounts of the counterparties are updated upon the buyer’s acceptance of the order.

In both cases a) and b), the invoicing takes place between the buyer and the seller.

- **Type:** select the **type** of GOs covered by the bilateral transaction²⁶ and the related production period²⁷ by using the drop-down menu:

- **year and energy source or use and the CNG (or CNG and LNG) label and the exportability specification**, if any;
- **production month or months:** select the production period indicating the month “da” (from)...”a” (to) (start month and end month of production); if you wish to specify a single month, for instance “January”, select “da Gennaio” (from January)... “a Gennaio” (to January).

- **Country of production:** select the country of production or the “non specificato” (not specified) option;

- Possible **support** received; specify any support received by selecting “SI”/”NO”/”NON SPECIFICATO” (yes/no/not specified);

- **Plant code (EAN):** you may specify the plant of origin of the GOs to be traded by entering the relevant EAN identification code, which must consist of 18 digits;

- **Volume:** specify the volume of GOs covered by the transaction;

- **Price:** enter the **unit price** (excluding VAT) expressed in €/MWh and specified with two decimals;

- **Buyer:** from the list of Participants, select the registered name/company name of the buying Participant and the related access profile²⁸ with which the latter will access the PB-GO to confirm the transaction. Note that, if the request for registration is submitted by selecting **a sale ad confirmed on the GO Bulletin Board**, then the list of buyers will be restricted to the operating profiles of the Participant who/which has confirmed such sale ad.

Then, by pressing “**Inserire offerta**” (enter order), you will get a summary window with the data of the entered transaction and the calculation of its total value. After checking the data, you may confirm the entry of the transaction by pressing “**Conferma**” (confirm) or cancel it with the “**Annulla**” (cancel) button (Figure 22).

You may view the entered transaction in the “**Transazioni bilaterali in vendita**” (bilateral transactions of sale) (Figure 20 – red area). By clicking on the row of a sale transaction, entered but not yet accepted by the buyer, you will get a window on which you may change the data of the transaction or cancel it.

4.1.2 Acceptance or rejection of a bilateral transaction by the buyer

In the “**Transazioni bilaterali in acquisto**” (bilateral transaction of purchase) (Figure 20 – green area), you may view the list of transactions for which the Participant, with a given access profile, has been specified as buyer. By clicking on the row for a given purchase transaction, you will get a window on which you may **accept**²⁹ or **reject**³⁰ the request for registration entered by the seller. In case of both acceptance and rejection, you must confirm the selection again.

If the seller has entered a bilateral transaction **without technical adequacy verification**, the latter is automatically validated upon the buyer’s confirmation. Indeed, in real time, the PB-GO management system will check the availability of the GOs being sold on the ownership account associated with the selling Participant’s profile in GSE’s GO Registry and, if the outcome is positive, it will validate the transaction and transfer the GOs from the seller’s ownership account to the buyer’s one. The stage of processing and transfer of the GOs might take from a few seconds to a few minutes; in this event, the transactions may be viewed in the “**Transazioni bilaterali in attesa di elaborazione da parte del GSE**” (bilateral transactions awaiting processing by GSE) section (Figure 20).

4.1.2.1 Management of transactions with technical adequacy verification and buying counterparties not qualifying as PA Participants

If the selling Participant has entered a request of registration of a bilateral transaction with technical adequacy verification and if the same has been accepted by the buyer, you will see it in the “**Transazioni bilaterali in attesa di validazione**” (bilateral transactions awaiting validation) area (Figure 20 – yellow area).

This section lists all the accepted transactions to which the Participant is a counterparty (both sale and purchase transactions), and which are awaiting GME's validations and/or technical adequacy verifications.

After GME's validation of the transaction, the GOs are automatically transferred from the ownership account of the seller to the one of the buyer. The stage of processing and transfer of the GOs might take from a few seconds to a few minutes; in this event, the transactions may be viewed in the "Transazioni bilaterali in attesa di elaborazione da parte del GSE" (bilateral transactions awaiting processing by GSE) section (Figure 20).

The list of transactions registered and accepted on the PB-GO may be viewed by clicking on "**Transazioni validate**" (validated transactions) (Figure 20).

4.1.2.2 Specific procedures for managing transactions with technical adequacy verification and buying counterparties qualifying as PA Participants

The registration of a transaction by an Italian selling Participant whose buying counterparty is a PA Participant, once accepted by the latter but pending confirmation from the Participants involved to GME about the delivery and consequent receipt of the electronic invoice, will be displayed in the "**Transazioni bilaterali in attesa di validazione**" (Bilateral transactions awaiting validation) area (Figure 20a - yellow area).

The legend that is available in the above section will clarify the status of the transaction in view of final validation by GME.

The transactions will be identified with different colours depending on the confirmations received, based on the legend posted in the same section.

By clicking on the transaction, the **selling Participant** may view a form summarising the registered data and have the option to click on the "Conferma" (confirm) button again to show that he/she/it has sent the electronic invoice.

When the transmission of the electronic invoice is confirmed, it will no longer be possible to correct the information (see the following Figure).

In view of the above, the registration of transactions between an Italian selling Participant and a PA buying Participant could make it impossible for GME to confirm the transactions based on their time of entry, specified by the selling Participant; consequently, there can be the temporary inability to use the amount of a sale with a PA Participant for subsequent bilateral purchases or purchases on the market.

The timing of confirmation of bilateral transactions with technical adequacy verification by GME, in the case of involvement of PA buying Participants, will not change and the confirmation will always be given on the day before each market session.

GME will proceed to the payment, on behalf of the PA buying Participants, by using their available deposit, as provided in Technical Rule no. 03 P-GO.

With reference to the GOs being traded, as currently envisaged, their validation and the verification of their presence in the ownership account of GSE's Registry, will occur upon confirmation by GME. Therefore, the selling Participant will have to maintain their availability on his/her/its ownership account.

4.2 Publication of the results of registrations on the PB-GO

On a monthly basis, GME publishes data and information (in aggregated form) about registrations of GO bilaterals. On its www.mercatoelettrico.org website, in the “Market results” section, GME publishes the following monthly data:

- a) volume and type of registered GOs, with the related production period;
- b) minimum price and maximum price;
- c) average price weighted for the registered volumes.

4.3 Publication of the results of auctioning procedures

On a monthly basis, GME publishes data and information (in aggregated form) about GO bilaterals resulting from auctioning procedures.

On its www.mercatoelettrico.org website, in the “Market results” section, GME publishes the following data:

- a) volume and type of registered GOs, with the related production period;
- b) minimum price and maximum price;
- c) average price weighted for the registered volumes.

5. MOVEMENTS IN THE OWNERSHIP ACCOUNTS ASSOCIATED WITH THE SAME PARTICIPANT

Participants with multiple access profiles may move their GOs from one of their ownership accounts to another of their ownership accounts, associated with the related access profiles³¹, by using the appropriate option available on the P-GO.

These movements will be allowed if they comply with the operating criteria of the access profiles, defined in the documents: 1) *DM GARANZIE DI ORIGINE – Regole Applicative* -



- **Type:** select the type of GOs involved by the movement³³ and the related production period³⁴ by using the drop-down menu:
 - **year and energy source or use and CNG (or CNG and LNG) label, with exportability specification, if any;**
 - **production month or months:** select the production period indicating the month “da” (from)...”a” (to) (start month and end month of production); if you wish to specify a single month, for instance “January”, select “da Gennaio” (from January) ...”a Gennaio” (to January).
- **Country of production;** select the country of production or the “non specificato” (not specified) option;
- **Support received;** specify any support received by selecting “SI/NO/NON SPECIFICATO” (yes/no/not specified);
- **Plant code (EAN):** you may specify the plant of origin of the GOs to be traded by entering the relevant EAN identification code, which must consist of 18 digits;
- **Volume:** specify the volume of GOs to be transferred to another account;
- **Recipient:** select the access profile to the account of which the specified GOs³⁵ are to be transferred.

After pressing “**Inserire Movimento**” (enter movement), the movement will be deemed to have been executed and will not need confirmation by the operating profile of the “destinatario” (recipient).

You may view all the movements made in the “**Movimenti validati**” (validated movements) section (Figure 24).



6.1 Preferred counterparties

In the “**Controparti Gradite**” (preferred counterparties) section of the GO Bulletin Board, you may view the status of requests of designation as a preferred counterparty sent, received, or confirmed/cancelled³⁶ (Fig. 26):



In both options/requests, you may include any other information as you deem useful for establishing a preferred counterparty relationship, by filling in an appropriate free-text “**Note**” (notes) field. If you select option 2) (request of designation of all Participants), the information specified in the “Note” field is considered to refer to all requests.

After completing the web form:

- if you have chosen option 1) (request of designation of a single Participant), select the “**Inserisci Richiesta**” (enter request) button. The platform will display a confirmation web form.

When pressing the “**Conferma**” (confirm) button (Fig. 30b):

- If you have chosen option 2) (request of designation of all Participants), select the **“Inserisci Richiesta”** (enter request) button. The platform will display a confirmation web form.

When pressing the **“Conferma”** (confirm) button (Fig. 30c):

- if a Participant receiving the request has in turn been a requesting Participant (mutual request), the system will automatically accept the request, thereby enabling the preference relationship. Thus, the confirmation of the designation request referred to in para. 6.1.3 below will take place automatically within the GO Bulletin Board system, without requiring any manual confirmation by the receiving Participant, since the request originates from the mutual intent expressed by Participants to establish a preference relationship between them. The Participant who/which has been the first to send the request will view the active preference relationship as a “proponent” in the “preferred counterparties” section (see para. 6.1), whereas the Participant who/which has sent the request subsequently will view the active preference relationship as a “counterparty” in the “preferred counterparties” section (see para. 6.1);
- for each of the remaining receiving Participants, the system will generate separate requests and:
 - if a receiving Participant has previously selected the “Accetta in automatico le richieste future” (automatically accept future requests) option as indicated in para. 6.1.3, the system will automatically accept the request, thereby activating the preference relationship;
 - if a receiving Participant has not previously selected the “Accetta in automatico le richieste future” (automatically accept future requests) option as indicated in para. 6.1.3, the system will place the requests in the pending status and the receiving Participant will have to “confirm” them manually, as set forth in para. 6.1.3 below.

The requesting Participant may change or delete the requests submitted (the change is allowed only for a single request, while the deletion is allowed either for a single request or for all requests), as long as they have not yet been accepted or rejected by the receiving Participants, or have not expired. To change or delete a single request sent, go to the “**Controparti Gradite**” section of the GO Bulletin Board and select, from the list of “**Richieste Inviaste**” (requests sent), the request that you wish to change or delete. The platform will display a web form with the details of the request. You may press the “**Modifica**” (change) or “**Ritira**” (withdraw) buttons, receiving another web form for confirmation.

6.1.2 Notifications about requests of designation as “preferred counterparties”

With a view to facilitating the management of requests of designation as “preferred counterparties”, the system has a notification option through which it notifies receiving Participants of requests of designation awaiting confirmation (see para. 6.1.3 below).

In particular, the information system sends a message to the receiving Participant (namely to the e-mail addresses of the contact persons for communications specified for the operating profiles authorised to access the GO Bulletin Board³⁸), inviting him/her/it to access the GO Bulletin Board and view the request received.

The notification option is activated automatically; however, the participant may disable it at any time by accessing the appropriate section in the GO Bulletin Board system.

After selecting the appropriate row, you will get a web form with the data sent by the requesting Participant. By clicking on “**Manifesta Interesse**”(express interest) near the ad, you may view the remaining data entered by the proponent.

The data of the

- **EAN plant code** (if entered by the proponent) can be viewed only by the Participant expressing interest in the ad;

The ways in which ads are displayed are the same for all the access profiles associated with the same Participant.

6.2.2 Submission of ads

To submit sale or purchase ads, go to the “**Annunci**” (ads) section of the GO Bulletin Board and click on the “**Nuovo Annuncio**” (new ad) button.

The platform will return a web form to be completed with the following data⁴¹:

- **Type***: select **VENDITA** (sell) or **ACQUISTO** (buy);
- **Type of GOs**⁴²: select the type of GOs covered by the ad and their production period⁴³ through a drop-down menu:
 - **Year of production**⁴⁴;
 - **Energy source or use and CNG (or CNG and LNG) label, with possible exportability specification**, where applicable;
 - **Month or months of production**: select the production period by specifying the month “da” (from)... “a” (to)... (month of start and end of production). If you wish to specify a single month, for instance “Gennaio” (January), select “da Gennaio” (from January)... “a Gennaio” (to January);
- **Production Country***: select among IT (Italy), EX (Foreign Countries⁴⁵), NON SPECIFICATO (not specified);
- **Support received***: you may specify whether you received a possible support for production by selecting “SI” / “NO” / “NON SPECIFICATO” (yes/no/not specified);
- **Plant code (EAN)**: you may indicate the plant of origin of the GOs by keying in the related EAN identification code, which must consist of 18 digits⁴⁶;

⁴² The selectable types of GOs will be those admitted from time to time to trading on the P-GO systems.

⁴³ On the GO Bulletin Board, the production period consists of a production year-month/s pair.

Thus, you may select the production year among the following values: n, n+1, ...n+10, where n is the production year still valid for trading upon entry of the ad. - **Installed capacity/plant size:** you may specify the size of the plant, expressed in MW;
- **Plant commercial starting date (entry into commercial operation);**
- **Quantity*:** specify the volume of GOs that you wish to sell or buy;
- **Price*:** specify the unit sale or purchase price;
- **Delivery date*:** specify the date within which all of the GOs will be delivered, by selecting it from an appropriate calendar. The date of delivery is valid if it is included in the period of tradability of the GOs associated with the ad:
- **Contractual model*:** select STANDARD CONTRATTUALE RECS (standard RECS contract) or ALTRO FORMAT (other format) and upload the declared reference contract format as a .pdf⁴⁷;
- **Notes:** free descriptive field where you may optionally enter additional data specifying the features of the sale or purchase ad;
- **E-mail address*:** specify the e-mail address to which expressions of interest in the ad are to be sent. This field will not be displayed in the ad but stored by the information system of the GO Bulletin Board to send notifications about ads. This e-mail address will be made available only to the Participant expressing interest in the ad;
- **Expiry date and time of the ad*:** specify the validity end date and time of the ad. After this date and time have expired, the ad will be automatically deleted from the GO Bulletin Board. The date and time of expiry of the ad are valid if they are included in the period of tradability of the GOs covered by the ad, and they must be earlier than or, at the latest, coincide with the date of delivery.

6.2.3 Validation of ads

The GO Bulletin Board information system will validate ads upon completion of the related submission web form by the proponent, ensuring that the ad contains all the minimum compulsory information for its submission (marked by an asterisk in the form) as laid down in the P-GO Rules. If the validation is successful, the system will enable the publication of the ad on the GO Bulletin Board.

6.2.4 Resubmission of an ad

To resubmit one of your ads into the GO Bulletin Board, if the ad is no longer visible in the list of “**Annunci Pubblicati**” (published ads), you may click on the “**Riproponi**” (resubmit) button (near the ad to be resubmitted) in the list of “**Annunci Confermati**” (confirmed ads) (Fig. 34).

Additionally, you may resubmit one of your own ads, if it has not yet been confirmed. To resubmit the ad, you may click on the “**Riproponi**” button (near the ad to be resubmitted) in the list of “**Annunci Propri**” (own ads) (Fig. 33).

After doing so, the platform will return a web form of the ad with pre-filled data that you may change before confirming its publication on the GO Bulletin Board.

6.2.5 Change and deletion of ads

If you have published an ad, you may change or delete it at any time, if it has not expired or if there has been no expression of interest therein.

To change or delete an ad already published on the GO Bulletin Board, go to the ANNUNCI (ads) section of the GO Bulletin Board, then to “**Annunci Propri**” (own ads), and select “**Dettaglio**” (detail) (Fig. 33) on the row concerning the ad of your interest. The platform will return a web form where you may change or delete the ad (after receiving a confirmation web form).

In particular, the information system sends a message to each Participant (namely to the e-mail addresses of the contact persons for communications specified for the operating profiles authorised to access the GO Bulletin Board⁴⁸), notifying the presence of new or changed ads.

The notification option is activated automatically; however, the participant may disable it at any time by accessing the appropriate section in the GO Bulletin Board system.

6.2.7 Expiry of ads

If, within its date of expiry, the ad has not received any expression of interest, it will be automatically deleted from GO Bulletin Board. The information system will notify the proposing Participant of the expiry of his/her/its ad, by sending an e-mail message to the e-mail address specified upon submission of the ad.

6.2.8 Expression of interest in an ad

Any expression of interest will be allowed only for ads submitted by Participants with which/whom there is an active preference relationship.

To express interest in an ad published on the GO Bulletin Board by another Participant, you must go to the ANNUNCI section of the GO Bulletin Board, then to “**Annunci Pubblicati**”. Here, near the ad of your interest, you must select “**Manifesta Interesse**” (express interest) (Fig. 34).

After doing so, the platform will display a web form that you must complete by entering your e-mail address (mandatory field)⁴⁹.

6.3 “Contatta” option – messaging about published ads

If you are interested in an ad published on the GO Bulletin Board, you may anonymously activate an exchange of messages (through the “**Contatta**” button placed near the ad, as shown in Fig. 34) with the proposing Participant, with a view to obtaining additional information about the ad before expressing interest therein. When enabling the chat, you may enter an e-mail address (which will not be shown to the proponent) for receiving message notifications.

The messaging option is only available for selectable ads and, before enabling it, you must accept the related disclaimer. **After an expression of interest in the ad, the “Contatta” option will be disabled.**

The presence of new chat messages will be notified to the Participants concerned through an e-mail message: the e-mail address of the proponent of the ad will be that indicated upon submission of the ad into the GO Bulletin Board, whereas the e-mail address of the Participant who/which has enabled the chat will be that indicated upon enabling the “**Contatta**” option.
