#### 1. Foreword

Article 2, para. 2.1 ccc) of the Rules governing the regulated market and the platform for registering bilaterals of guarantees of origin (hereafter P-GO Rules) provides that type of GO shall mean one of the types of GOs among those identified in the Technical Rules.

Article 23, para. 23.2 of the P-GO Rules provides that the value of GOs traded in the M-GO shall be defined in the Technical Rules.

Article 23, para. 23.3 of the P-GO Rules provides that the types of GOs tradable in the M-GO shall be defined in the Technical Rules.

Article 30, para. 30.1 a) of the P-GO Rules provides that bilateral transactions between operators, concerning GOs of the value specified in the Technical Rules, differentiated on the basis of their type as per Article 23, para. 23.3 of the P-GO Rules and of the related production period as per Article 23, para. 23.4 of the same Rules, shall be registered on the PB-GO under the procedures set out in Section II, Subsection I of the same Rules.

Article 30, para. 30.1 b) of the P-GO Rules provides that bilateral transactions, resulting from the auctioning procedures organised and managed by GSE under ARERA's Decision ARG/elt 104/11 and concerning GOs of the value specified in the Technical Rules, differentiated on the basis of their type as per Article 23, para. 23.3 of the P-GO Rules and of the related production period as per Article 23, para. 23.4 of the same Rules, shall be registered on the PB-GO under the procedures set out in Section II, Subsection II of the same Rules.

### 2. Types of GOs

The types of GOs that may be traded in the M-GO, registered on the PB-GO, or associated with ads on the GO Bulletin Board are as follows:

## 3. Value of GOs

The value of GOs shall be equal to 1 MWh.
