

Technical Rule no. 01 PAR

(pursuant to Article 4 of the Regulation of the Platform for the Allocation of Regasification Capacity, approved by Autorità di Regolazione per Energia Rete e Ambiente with Resolution 111/2018/R/gas)

Title	Notification regarding the procedure for the admission/exclusion from the PAR

1. Foreword

Article 11, paragraph 11.1, provides that the parties wishing to participate in the platform shall submit to the GME a PAR participation application, drawn up according to the specific format attached to the Regulation (Annex 1), together with the documentation referred to in Article 12 of the same Regulation, as well as a signed copy of the PAR Participation Agreement, drawn up according to the specific format attached to the Regulation (Annex 2).

Article 13, paragraph 13.1, provides that GME, upon verification of the regularity of the documentation submitted for the purposes of admission to the PAR, within 15 calendar days from the date of receipt of the request and according to the procedures and terms defined in the Technical Rules, shall notify admission or rejection of the application.

Article 13, paragraph 13.3, provides that GME, if the documentation submitted for the purposes of admission to the PAR is irregular or incomplete, shall inform the interested party, according to the procedures and terms defined in the Technical Rules, about the procedures necessary to regularize or complete the documentation, as well as the deadline to fulfill these obligations.

Article 19, paragraph 19.1, provides that participants, for the purposes of exclusion from the PAR shall submit at GME or forward, according to the procedures and terms defined in the Technical Rules, a specific written request, indicating the date from which the exclusion is required.

2. Terms and modalities for sending notifications by GME

GME shall notify by registered letter with return receipt or by CEM:

- the admission of the participant to the PAR, or the rejection of the participation application within 15 calendar days from the date of receipt of the same application (Article 13, paragraph 13.1);
- if the documentation submitted is irregular or incomplete, the procedures necessary to regularize or complete the documentation, as well as the deadline to fulfill these obligations (Article 13, paragraph 13.3).

3. Terms and modalities for sending notifications by the party requesting admission/exclusion to PAR

The party requesting the admission/exclusion to the PAR shall submit/send to GME by ordinary mail or courier or by CEM:

- the PAR participation application, drawn up in accordance with the specific format attached to the Regulation (Annex 1), signed in original by the natural person or by the legal representative or by the person with the necessary powers (Article 11, paragraph 11.1, subpara. a));
- the documentation referred to in Article 12 of the same Regulation, signed in original by the natural person or by the legal representative (Article 12, paragraph 12.1);
- the PAR Participation Agreement, drawn up according to the specific format attached to the Regulations (Annex 2), initialed on each page and signed at the bottom, in original, by the natural person or by the legal representative (Article 11, paragraph 11.1, subpara. b));
- the request for exclusion from the PAR signed in original by the natural person or by the legal representative or by the person with the necessary powers (Article 19, paragraph 19.1).
