1. Foreword

Article 22, paragraph 22.2, of the Regulation provides that for products concerning the allocation of annual and multi-annual capacity without indication of the date of output, before the beginning of each session, GME shall notify the participants, according to the procedures and within the terms indicated in the Technical Rules, about the technical specifications of the tradable product.

Article 22, paragraph 22.4 of the Regulation provides that for products concerning capacity slots during the thermal year without indication of the date of output or with indication of the exact date of output, as well as for residual products in thermal year, before the beginning of each session, GME informs participants about the technical specifications of the tradable product, according to the procedures and within the terms indicated in the Technical Rules.

2. Technical specifications of annual and multi-annual products

The technical specifications of the annual and multi-annual products are made available by GME, on the related PAR segment, within the order book of the product being traded, within the opening hours of the session for the submission of offers. In particular, GME makes at least the following information available:

- a) number of slots/capacity to be allocated;
- b) reserve price (P);
- c) reserve price (R);
- d) high price steps and low price steps for each reserve price;
- e) relevant period.

3. Technical specifications of the products available during the thermal year and residual thermal year

The technical specifications of the products available during the thermal year as well as of residual products in thermal year, are provided by GME, in the relevant segment of the PAR, within the order book of the product being traded, no later than the opening hours of the session for the

submission of offers, provided that the corresponding regasification company has notified to GME all the information of their respective competence provided for in Article 26 of the Regulation. In the case of allocation of capacity issued, the corresponding slots/products are made available by GME, on the reference PAR segment, within the order book of the related product being traded, only after the participant (who has issued the capacity) has notified GME about the reserve price pursuant to the Technical Rule no. 08 PAR.

In particular, GME makes the following information available:

- a) number of slots to be allocated;
- b) relevant period;
- c) indication of the unloading date (if any);
- d) the calendar of the unloading dates at the terminal, where applicable.

With reference to the residual product in thermal year, the number of slots to be allocated corresponds to the number of unloading slots associated with each month constituting the single product.
